## Puppy Purchase Contract

### Intent:

It is our firm intention to produce only quality breedable animals free of genetic defects. Our primary goal as Breeders is to produce animals which are a credit to the breed and to place them in homes where they will receive excellent physical and mental care.

This contract outlines the rights and responsibilities of the Breeder and the Purchaser. Breeder will refer to Cattle Rustler Kennels, Purchaser will refer to the original buyer (owner) of the puppy whose name(s) appears on this contract and on the registration form. In a case of co-ownership, the person(s) who retain physical custody of the animal will be the party covered under this contract. This contract is made with the original Purchaser only. If the animal is resold, this contract is void.

### For Breeding Quality Animals Only!!!

The purchase price for a breeding/working/show animal will be \$\_\_\_\_\_. This determination of quality will be made by the Breeder at the time of sale. Papers indicating that the animal is for breeding stock will be issued.

### The Breeder Guarantees As Follows:

- 1. Lifetime Temperament Guarantee** - If, at any time during the life of a breedable quality **Cattle Rustler Kennels Alapaha**, he/she is found not to be compatible with the situation of the original purchaser, return him/her and the ABBA papers to the kennel, and he/she will be replaced at no charge. The owner's "word" is all that is needed for replacement. The animal must be in good condition.
- 2. Money-Back Guarantee** - A refund of One-Thousand dollars U.S. will be refunded if your breedable **Cattle Rustler Kennels Alapaha**, receives a Shutzhund, Ring or IWPA title. If the dog achieves SchIII, FRIII or obtains a IWPA gold medal, a 100% refund of the purchase price is available.
- 3. Lifetime Guarantee Against Dysplasia** - If, at any time during the life of a **Cattle Rustler Kennels Alapaha**, he/she is found to be crippled from dysplasia, return him/her to the kennel, along with the ABBA papers and we will replace the dog at no charge. (This guarantee only applies to dogs that were X-rayed by the age of two years either OFA or PennHip. If there is any evidence of trauma or injury this contract is void.

4. **Lifetime Parvo Virus Guarantee** - If your Cattle Rustler Kennels Alapaha, dies from Parvo virus, return the ABBA papers along with laboratory verification and we will replace him/her at no charge. The guidelines for Parvo boosters are outlined in the puppies vet records supplied to the new owner at time of purchase or on the web at [www.oldplantationbulldogs.com/faq](http://www.oldplantationbulldogs.com/faq). If the Parvo boosters are not done as specified this contract is void.

5. The Breeder will provide a Certificate of Health issued by the Breeder's Veterinarian upon delivery of the puppy. The Purchaser is required to have the animal examined by his/her own Veterinarian with 72 hours after delivery of the animal.

6. The puppy will be immunized by the Breeder for common canine diseases as appropriate for the age of the animal. Vaccination records will be provided. The Purchaser is responsible for all subsequent vaccinations. Failure to properly vaccinate the animal will render this contract void. Proof of vaccination may be required by the Breeder.

7. The Purchaser is responsible for routine and necessary Veterinary care from the date of delivery of the animal. If the health of the animal is compromised due to physical neglect or lack of or withholding of Veterinary care this contract is void.

8. If the animal exhibits a life-threatening or severe life-altering condition which is a result of congenital defect within the first 24 months of life, the Breeder will respond as follows:

- A. Veterinary records documenting the condition of the animal must be provided at the Purchaser's expense.
- B. At the Breeder's discretion, the Breeder may require examination by a Veterinarian of the Breeder's choice. Transportation of the animal to the Breeder and any expense incurred therein will be the responsibility of the Purchaser. Additional veterinary expense will be the responsibility of the Breeder.
- C. In the case that the animal is deceased, the Breeder required that a complete autopsy be performed to ascertain the cause of death and documentation be forwarded to the Breeder's Veterinarian. Before euthanasia is administered, the Breeder must be consulted or this contract is void.

Providing the above terms are met, replacement or refund will be as follows:

- A. Within a period of time agreed upon by the Breeder and the Purchaser but not less than 6 months from the initial notification of the problem a replacement puppy will be provided by the Breeder if a suitable puppy becomes available
- B. If a puppy is not available during the agreed upon interval, the Breeder will refund the purchase price as follows.
  - 1. If the defect has caused the death of or required euthanasia of the animal, the purchase price will be refunded
  - 2. If the defect has rendered the animal unsuitable for breeding (judgement of the Breeder and Breeder's Veterinarian), but has not seriously compromised the health or longevity of the animal, the difference in cost for a breeding quality animal (\$ \_\_\_\_\_) versus a pet quality animal (\$ \_\_\_\_\_) will be refunded or applied to the purchase of another animal (if one should become available as agreed above) **only after the animal in question has been spayed/neutered**. The original papers must be surrendered to **CATTLE RUSTLER KENNELS**. New papers will be issued to the Purchaser indicating that the animal is not for breeding stock.

**Restrictions: (Please initial next to each number to indicate agreement)**

- \_\_\_ 1. In the event that the Purchaser is unable to care for the animal, the Breeder must be notified and given first opportunity to purchase the animal at or below the initial purchase price.
- \_\_\_ 2. If the Purchaser is found guilty of violations of the Animal Welfare or Animal Abuse laws, ownership of the animal will revert to the Breeder without refund of money.
- \_\_\_ 3. If the Purchaser uses the animal for the purpose of dog fighting, ownership of the animal will revert to the Breeder without refund of money.
- \_\_\_ 4. If the Purchaser agrees never to sell the animal or any progeny of the animal to any Pet Store, Pet Farm or other similar Puppy Sales institution.
- \_\_\_ 5. The Purchaser agrees to retain the original registered name of the animal.
- \_\_\_ 6. If the animal is used for breeding, the Purchaser agrees to have the animal's hips and elbows examined radiographically for evidence of hip or elbow dysplasia prior to breeding. The Purchaser will provide a copy of the X-rays to the Breeder.
- \_\_\_ 7. The Purchaser is solely responsible for the behavior of the animal after purchase. The Breeder retains no liability for the animal's actions.
- \_\_\_ 8. **To ensure the survival of our breeding program CATTLE RUSTLER KENNELS reserves the right to breed to any breedable male pup produced or sold by us twice (2 times) for Free! Any cost (i.e., vet bills, shipping or travel) incurred will be paid by CATTLE RUSTLER KENNELS.**
- \_\_\_ 9. All dogs produced or sold by CATTLE RUSTLER KENNELS will carry the CRK prefix before any other name on their registration papers. We also reserve the right to advertise pictures and/or video footage of any dog sold or bred by us.

Limitations of Guarantee - This guarantee applies to the original puppy only and is non-transferrable. The puppy must be in good physical condition. No replacement will be given if the male or female has been bred, neutered, spayed or registration application form has been lost or expired. Owner is responsible for transportation costs to and from kennel.
